The Conservancy has primary responsibility for maintaining the McGovern Centennial Gardens. Our gardeners and maintenance team serve as ambassadors for the Gardens-educating visitors and training volunteers to have a meaningful experience as they provide critical help to keep the Gardens flourishing.




